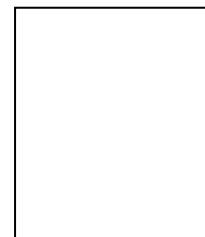

#### **Essential Minimum Age, Professional Qualifications and Experience for Nominees:**

- Age: Minimum 21 years on the date of application.
- Fellow Member (FIMQE): Doctorate Degree in Engineering or Masters Degree in Engineering with Five Years Experience or Bachelors Degree in Engineering with Ten Years experience or Superintending Engineers grade and above in Government Departments and Undertakings or Professor grade and above in Engineering Institutions.
- Member (MIMQE): Masters Degree in Engineering or Bachelors Degree in Engineering with Five Years experience or Divisional Engineers grade and above in Government Departments and Undertakings or Associate Professor grade and above in Engineering Institutions.
- Associate Member (AIMQE): Bachelors Degree in Engineering or Assistant Engineers grade and above in Government Departments and Undertakings or Assistant Professor grade and above in Engineering Institutions.
